Please read and agree to below contract and prices as per outlined in the price schedule above

- Convoy will be standing at ‘Mianga’ Coolah for live covers. If a collection is required during this time and he is transported to Quirindi, transport fee of \$200 per trip will apply.
- The Stallion Fee stated above **includes a non-refundable booking fee** which shall be payable upon execution of this contract. The balance shall be payable when the mare is pronounced 30 days in foal. This booking fee is valid for one breeding season only, unless a rebreed is required, in which case, it must be used the year immediately following initial breeding. The mare will not be bred until booking fee is paid.
- Remaining balance of service fee and agistment for mares at ‘Mianga’ will be paid to Troy & Fiona Palmer. Agistment costs are required to be paid before the mare is collected from ‘Mianga’ by the owner.



- Any veterinary fees for scans and general care of the mare whilst at 'Mianga' will be charged to the mare owner by Coolah Vet Clinic.
- Troy Palmer (Hereinafter "TP") agrees to provide suitable facilities for the care and feeding of the mare and/or foal while in his custody.
- The mare owner agrees to fees schedule above.
- TP will exercise judgment in care and supervision of the mare and/or foal. Mare owner hereby consents to all medical care administered to the mare and/or foal by TP's veterinarian. Mare Owner will pay all veterinarian and any other expenses as required.
- The mare shall be healthy and in sound breeding condition; free from infection, contagious or transmittable disease. The mare must be halter broke and able to be hobbled. A photocopy of the registration papers should accompany the mare or be emailed to TP.
- The contract contains a "Live Foal Guarantee". A live foal is described as a new born foal which stands and nurses without assistance. If the foal is born dead or does not stand and nurse, return privileges shall only apply to the next normal breeding season.
- If the mare miscarries, proves barren after being pregnancy checked in foal, or fails to conceive during normal breeding season, TP agrees to breed said mare again during the following breeding season. A substitute mare may be sent if the original mare is deemed unfit for breeding at the discretion of TP, as long as mare owner has maintained the bred mare in good condition during the term of her pregnancy.
- Upon mare owner's request, a 'Breeder's Certificate' will be issued for the foal conceived by the mating when TP has had all stallion fees and all other expenses paid in full. AQHA Breeding Returns to be requested by March 2024. If a late AQHA breeding return is required the mare owner is responsible to pay the late fee required by the AQHA. ASH breeding certificates will be issued on request.
- In the event that twin embryos are born, a second, full service fee will be charged.
- ALL CARE WILL BE TAKEN TO LOOK AFTER MARE AND/OR ITS FOAL. THE MARE OWNER AGREES THAT TP AND/OR HIS WORKERS WILL NOT BE RESPONSIBLE FOR ANY ACCIDENT, INJURY, SICKNESS OR DEATH TO THE MARE OR ITS FOAL WHILST IN HIS CARE.
- Should stallion die or become unfit for service for any reason any expenses incurred such as agistment, veterinary fees etc shall be paid by the owner. If the mare dies then this contract should become null and void and both parties are relieved of any further obligation hereunder and any monies paid by the mare owner toward the Stallion Fee, with the exception of the NON-REFUNDABLE BOOKING FEE, shall be refunded to the Mare Owner.

I/We agree that the attending veterinarian check my mare for normal breeding conditions and perform such other veterinary services as is deemed necessary at mares owners expense. All mares must be halter broken and able to be hobbled. The stallion owner or agent reserves the right to refuse any mare for service.
