The Mare Owner will be responsible for payment of all charges for veterinary (including collection, insemination fees, scanning, treatment drugs, worming, treating infections, preventive measures, examination etc. as necessary), Mare handling fees, agistment of the Mare, semen transport fees if applicable, and any other Mare related expenses. 2. It is agreed that the chosen Veterinary Clinic is independent of the Stallion Owner and the Stallion Owner shall not be responsible for any injury to the Mare or her progeny or loss incurred by the Mare Owner however caused. Nor shall they be responsible for any disease, accident, sickness or death to the Mare or foal. 3. It is further agreed that should the Stallion die or become unfit for service, or the above-named Mare should die, then this contract shall become null and void, any money paid as part of the booking fee shall be refunded. Agistment and Veterinary Fees must be paid to the nominated breeding centre where required. 4. If the Mare shall not become pregnant after appropriate veterinary attention (documentation supplied to Stallion Owners as proof) and after all reasonable diligence to settle the Mare has been undertaken both by Mare Owners and your nominated breeding centre, the Stallion Owner's liability shall be limited to refunding the balance of the deposit (excluding non-refundable booking fee of \$440.00 inc GST). It is the Mare Owner's responsibility however to pay all fees (if required) for agistment and veterinary expenses. 5. If the Mare aborts or if the foal does not stand and nurse, it is agreed that the Owner may return the Mare for breeding during the following breeding season and no stud fee will be charged for subsequent breeding (vet & agistment will not be included and remain Mare Owners expense). To be entitled to such subsequent breeding, the Owner must deliver to the Stallion Owners, a certification by a licensed veterinarian attesting that the Mare aborted or that the foal failed to stand and nurse, accompanied by the Stallion Breeding Certificate, and such delivery shall be made within ten (10) days of the date that the Mare aborts or the foal is born.

6. Australian Quarter Horse or Australian Stock Horse Society breeding certificates will not be issued unless the

late fee required by the above mentioned.

- 8. It is agreed that all sums payable to Stallion Owners (includes non-refundable booking fee of \$440 inc GST, and the balance of the Stallion Service Fee payable on 45-day positive scan) A booking fee invoice will be sent to your nominated email address once we have received your completed breeding contract.
- 9. When the Mare Owner signs and returns two copies of this contract to the Stallion Owners including a copy of the Mares' registration papers and the deposit is paid upon invoice, it will then be a binding contract for both parties' subject to the above terms and conditions. This contract is not transferable or assignable unless negotiated between both parties.
- 10. The semen will be collected at Jara Park as above; The Mare Owner agrees to pay the shipping or transport costs to deliver the semen to your nominated breeding centre's address and any additional collection fees required. Semen is available with prior notice only and Mare Owners must be aware that if semen is needed over the weekend or out of business hours' additional fees may be charged to them. If this is so semen will only be available if the vet is available, and transport is possible during this period. The quantity and quality of semen shipped is deemed to have sufficient numbers and motility to obtain pregnancy under normal conditions if inseminated within 24 hours or as per the agreed Veterinary Clinic's instructions. Semen will be transported in a foam-chilled box and must be kept in a cool area when transported. If going via bus transport the semen must travel near the driver in the air conditioning or alternate transport methods must be organized by Mare Owners (may consult with the agreed Veterinary Clinic for suitable methods if known) and must arrive and be inseminated within a 24-hour window or as per the agreed Veterinary Clinics instructions. The Stallion Owner or the agreed Veterinary Clinic are not liable for Semen lost in transport or for delays in semen arriving to its destination and /or if this causes loss of motility to the live semen. The Mare Owner is responsible for any costs. Where additional semen is required, Mare Owners are to pay the additional collection fees and shipping expenses to the nominated breeding centre before additional semen is shipped.
- 11. Live Cover is only available to mares that have been vetted by our attending Vet "5 Starr Equine Vets- Dr Sophie Starr". Live Cover is only available to mares that have been trained with restraints eg. Breeding Hobbles, Collar Rope and that Mares may be given sedation under veterinary direction The Mare Owner understands that mares will have their tails wrapped and genital cleaned prior to breeding. Live Cover will incur a Mare Handling Fee of \$198inc.
- 12. In the event of twin embryos surviving you will be invoiced for any subsequent pregnancies.
