- 2. Live Foal Guarantee: Any mare which does not produce a live foal is entitled to a return in the following breeding season. This is non-transferable unless agreed upon by Neilsen Cutting Horses. This guarantee will only be valid if Neilsen Cutting Horses are notified within 7 days of the Birth of the foal. All costs related to getting the return mare in foal are the responsibility of the mare owner.
- 3. Pregnancy status to be confirmed no later than 45 days from last day of service where practical.
- 4. HERDA Guarantee. We do not recommend that a known HR/N carrier be bred to Pimped up cat. However, if a HERDA HR/N carrier is inadvertently bred to Pimped up Cat and the resulting foal is found to be HR/HR after testing, the mare owner will be entitled to a rebreed using an alternative mare. All costs in getting the mare in foal are the responsibility of the mare owner.
- 5. Obligation of the mare owner: The mare must be presented in a healthy condition suitable for breeding. Substitution can be considered on vet advice (Vet Certificate) and authorisation by Neilsen Cutting Horses. Registration Papers of the substitute mare will be required.
- 6. Release: This contract is non-transferable unless prior consent is given by NEILSEN CUTTING HORSES.
- 7. No semen will be shipped until **payment in full** of the breeding fee and a signed contract and mare registration papers are received.
- 8. This contract is for the supply of Chilled or Frozen semen.
- 9. Neilsen Cutting Horses will endeavour to make Chilled semen available during the breeding season. However, if due to illness or show commitments Chilled semen is unavailable, we will endeavour to make Frozen semen available.
- 10. Costs for the collection and shipment of Chilled semen or the shipment of Frozen are the responsibility of the mare owner.
- 11. Breeding certificates will be issued at no cost to AQHA registered mares.
- 12. Registration applications to other breed organisations will be done on a best endeavour basis at the cost of the mare owner.
- 13. This contract is valid for two (2) breeding seasons.
