- 2. SERVICE FEE payable for the 2024/20245breeding season is \$1980.00 INC GST.
- 3. Booking FEE of \$500 (non refundable) is payable at the time of booking the mare to stud and returning the breeding contract. The booking fee is deductable from the breeding fee and is valid for one breeding season only (including semen orders). One form per mare required, please attach a copy of the mares registration papers.
- 4. Balance of the breeding fees are due to be paid in full, prior to the collection or on the day of collection of the stallion.
- 5. A Live Foal Guarantee will be offered with this service fee, a free return service to the stallion must be used the following season the year immediately following this agreement. If the mare is not returned or her owner fails to return her to breed the following season, any and all fees will be forfeited and the guarantee is null and void. All collection and semen postage fees are to be paid by mare owner. If the mare dies, is unsuitable to breed or is sold then the right to a Free Return is null and void. 2FL Syndicate must be informed within 1 week from death of foal and given a statement from a licensed veterinarian of the death and that the mare is suitable for re-breeding.
- 6. In the event that the stallion dies or becomes unfit for service, or the above named mare should die this contract becomes null and void, any money paid as part of the booking fee shall be refunded.
- 7. The owner agrees to pay all charges including GST applicable to the mare and/or progeny for, but not limited to, collection fees (to the agreed Veterinary Clinic), agistment fee, all treatments, examinations, procedures, operations and costs for the mare to be bred to the above stud.
- 8. All semen transport fees are to be paid by Mare Owner if applicable.
- 9. 2FL Syndicate is not responsible for lost, damaged or delayed shipments.
- 10. As much notice is required for shipped of chilled semen, at a minimum 48 hours. A semen request form must be completed and returned to 2FL Syndicate prior to shipping.
- 11. Semen must be used to breed 1 foal to the mare and not to breed to another mare or breed more than 1 foal.
- 12. The mare to be bred shall be healthy, in sound breeding condition.
- 13. The mare owner is to inform 2FL Syndicate via email or phone the 42 pregnancy scan result.
- 14. AQHA and ASH breeding certificates will not be issued unless the mare is registered with those associations. Only owners who have paid in full will receive a certificate. If a late stallion breeding return is required, the owner is liable to pay the late fees required by ASHS/AQHA. Any testing required for the registration of the foal is the responsibility of the mare owner.
- 15. When the mare owner signs and returns this contract to the stallion owners, including a copy of the mares registration papers and the deposit mentioned in clause 3, it will then be a binding contract for both parties' subject to the above terms and conditions.
- 16. The semen will be collected at the nominated veterinary clinic chosen by the stallion owners, the mare owner agrees that if semen needs to be collected outside standard veterinary hours that the mare owner is responsible for after hours fees and weekend costs.
- 17. For any ET that result in twin embryo fertilisation the mare owner must pay a second service fee to 2FL Syndicate if they wish to receive a service certificate

Terms and Conditions:

- 1. Campdraft must be an ACA affiliated draft and must be run under ACA rules.
- 2. Open must be a 3 round open, Novice must be a 2 round.
- 3. Incentive excludes Restricted Open, Ladies, Encouragement, Furtuiry, Maiden for Maiden, Jackpot Drafts, Juvenile and Junior.
- 4. Progeny is only eligible if service fee is directly purchased through the 2FL Syndicate beginning 07/02/2022. Progeny is also eligible if purchased through a Nutrien Classic, Supreme, Fountain of Youth or Willinga Park Sale, or through any Nutrien Horse sale.
- 5. If foal / horse changes hands or is sold <u>privately</u> all incentives are null and void. Only horses resulting from breeding's to PCD Reyning Metal under the 2FL Ownership are eligible.
- 6. Payment will be made within 30 days of the official ACA campdraft results been listed or 60 days from competition of campdraft.
- Once incentive has been won incentive is no longer applicable for that event. For instance if the Open is won it is no longer applicable but the novice and maiden prizes still stand.
- 8. If PCD Reyning Metal dies or becomes unfit to breed this incentive program will be null and void.
- 9. The incentive program may be added to at the discretion of the 2FL Syndicate.
