- 1. Fees Service Fee is \$3,300 inc GST
- Vet Fees are also additional. All veterinary charges will be billed separately and must be paid by the Mare Owner. This cost includes but not limited to collection, insemination, scanning, treatment drugs, worming, treatment, examination ect. As necessary, mare handling fees, agistment, semen transport, and any other related fees, are also an additional cost invoiced to the mare owner.
- Booking Fee of \$300 inc GST is payable on return of this Contract. This Booking Fee is non-refundable and is deducted from the service fee and is valid for one breeding season only. Mares will not be covered until the Booking Fee is received.
- Balance of Service Fee to be paid after a 45 day pregnancy test

- 2. Live Foal Guarantee is given with the return privilege for the following season. It is understood that if the foal dies within 48 hours of foaling, or if stillborn, in both cases a report certificate by a practicing Veterinary Surgeon is required within 10 days of the date of the foals death. To be entitled to such subsequent breeding, the mare owner must notify the Stallion Owner within 48 hours of foaling. If the mare is returned to competition after being serviced, this guarantee will not be valid. It is then agreed that the Owner may return the mare the following breeding season and no additional Service Fee will be charged, for one season only, other associated charges will still apply. If the mare dies, is sold, or becomes unsuitable to breed, the right to a free return is null and void.
- 3. If Stallion/Mare become Unfit for Service if either the mare or stallion die or become unfit for service then is contract shall become null and void. Agistment and Veterinary Fees must be paid by the mare owner where required.
- 4. Breeding Certificate The Mare owner is to inform one of the owners from TurnerMarks Equine for the result of the live foal (within 48 hours of being born). A breeding certificate will be issued to the mare owner. In the event of twins via embryo transfer, two service fees will need to be paid to obtain a second breeding certificate. A breeding certificate will not be issued unless the above mentioned Mare is registered with the Associations listed above, at the time of signing this contract.
- 5. Contract When the Mare Owner signs and returns the Contract to the Stallion Owners including a copy of the Mares registration papers and the Booking Fee, it will then be a binding contract for both parties' subject to the above terms and conditions. This contract is not transferable or assignable.
- 6. Collection Centre It is agreed that the chosen collection centre is independent of the Stallion Owner and the Stallion Owner shall not be responsible for any injury to the mare or her progeny or loss incurred by the Mare Owner however caused. Nor shall they be responsible for any disease, accident, sickness, or death to the Mare or foal.
- 7. Shipped Semen will be collected at the Collected Centre mentioned above. The Mare Owner agrees to pay the transport costs to deliver the semen and any additional collection fees required. Semen is available with prior notice only and Mare Owners must be aware that if semen is needed over the weekend or out of business hours' additional fees may be charged to them. If this is so the semen will only available if the vet is available and transport is possible during this period.

The Stallion Owner or the agreed Veterinary Clinic are not liable for Semen lost in transport for the delays in semen arriving to its destination and /or if this causes loss of motility to the live semen. The Mare Owner is responsible for any costs. Where additional semen is required Mare Owners are to pay the additional collection fees and shipping expenses to the nominated breeding centre before additional semen is shipped.
