### **CAT N A HAT BREEDING AGREEMENT**

The service fee for the 2024-25 breeding season is \$2640 inc GST, this includes a \$440 inc GST non-refundable booking fee. The full-service fee amount of \$2200 inc GST is payable on 45 days positive pregnancy test.

### **TERMS AND CONDITIONS**

1. This breeding entitles the mare owner to a live foal guarantee. If the foal dies within 48 hours a certificate by a qualified veterinarian will allow for a re-breed.
2. The mare owner clearly understands the amounts stated above do not include any veterinary, shipping, agistment, or other costs incurred in achieving a pregnancy.
3. The mares Registration Certificate showing owner(s) at the time of breeding must be returned with this contract.
4. Semen will not be shipped until booking fee is paid, a signed contract and a copy of mare's registration papers are on file.
5. There will be no guarantees or warranties for shipped semen. The stallion owner and Beef Breeding Centre will not be held liable for contamination or damage of semen during or after shipment, including loss of viability, or any costs arising from shipments that are delayed, damaged or lost in transit.
6. 24 to 48 hours notice to be given to Kelly O'Toole at Beef Breeding Centre Rockhampton prior to needing semen.
7. It is further understood that should Cat N A Hat become injured or passes away and is unable to collect semen or Live Cover, then the Mare Owner(s) will have access to 1 Dose of frozen semen to fulfil the needs of this contract.

8. Kelly O'Toole at Beef Breeding Centre Rockhampton reserves the right to refuse the breeding of any mare that does not have ideal health and or handling standards.
9. To obtain a breeder's certificate you must notify David Bell or Teah Beak of the 45 day positive pregnancy. Certificate will not be issued if the account has not been paid in full.
