1) I hereby agree to breed my mare/reg no: \_\_\_\_\_  
SMITH FAMILY CONJESSMAN this 2024/2025 breeding season. The breeding fee of \$2,750 (incl GST),  
(excl collection + mare vet fees.)

The mare's registration certificate showing the owner at the time of breeding or a photocopy of both sides, thereof, must be furnished and returned with this contract.

2) A booking fee of \$200 is payable (deductible/nonrefundable) with this contract to confirm booking. The balance of the unpaid stud fee is to be paid when the mare is pronounced safe in foal at 45 days. No breeding certificate will be issued until account for mare has been paid in FULL.

3) Bryan must be notified of a positive or negative pregnancy before the **28th of Feb 2025** to make sure the Breeding return can be lodged on time. If notified after this time the cost must then be covered by the mare owner and will need to be paid before you are issued with a breeding certificate.

4) The mare owner clearly understands that the amounts stated above do not include any veterinary costs incurred in achieving a pregnancy.

5) If Semen is to be shipped Mr Bryan Proctor & the Berragoon Breeders team guarantee to ship high quality semen. There will be no guarantees or warranties for this shipped semen and we will not be held liable for contamination or damage of semen during or after shipment, loss of viability or any costs arising from shipments that are delayed, damaged or lost in transit.

7) If more than one foal results from any one embryo flush or breeding, **an additional Stallion Breed Fee of \$2,750 (incl GST)** will be due and payable to Bryan Proctor upon each successful 45 day pregnancy scan of said embryos.

8) Mare owner agrees to notify Bryan of the pregnancy status of the mare as soon as she is checked for pregnancy regardless of whether she is pregnant or not.

9) The mare owner is guaranteed a live foal at the time of signing this contract. If the foal does not stand and suckle, the mare owners will be entitled to a rebreed to the same mare until a healthy live foal is achieved. This guarantee will only apply if the mare owner notifies Bryan within one week from the foal's death. This notice must also be accompanied by a statement from a licenced veterinarian. There shall be no liability upon Mr Bryan Proctor on account of said guarantee except to grant the mare owner a rebreed for the same mare until a successful healthy live foal is achieved. A rebreed contract will need to be completed and returned to Bryan Proctor immediately.

10) The live foal guarantee for this contract (mare) is non-transferable and non-assignable unless authorised by Bryan Proctor. Should the mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee will be void. (unless prior authorisation by Mr Bryan Proctor)

11) All expenses including shipment incurred in achieving rebreeds shall be borne by the mare owner.

12) When mare owner signs and returns one copy of this contract with payable to Bryan Proctor, and deposit is paid, it will be binding contract on both parties and subject to the above terms and conditions. Mare owner agrees not to assign or transfer this contract without consent of Mr Bryan Proctor.
