## **STALLION SERVICE CONTRACT**



Between Beau & Emily Frame ("the Stallion Owner")

and "the Mare Owner", \_\_\_\_\_ This agreement will apply to "the mare",

Owned by the mare owner for service to the stallion 'TELES TWO TIMES' subject to the following terms and conditions:

1) SERVICE FEE: a) **CHILLED SEMEN**: The service fee payable **is \$2200** (incl. GST) + Vet costs. A **\$330** (incl. GST) booking fee must be paid in full prior to shipment of chilled. The booking fee is non-refundable and is deducted from the service fee. The balance of the service fee is payable upon 45 days positive pregnancy test.

b) **FROZEN SEMEN:** A service fee of **\$2200** (incl. GST) + Vet costs for **2 x 8 straw doses** is agreed upon and made payable with the contract to confirm booking. Frozen semen is sold and required to be paid in full prior to the semen being released. The owner will be allowed two attempts to receive a positive result at the breeding price, **on the third and beyond attempt a \$300 semen fee is payable**. Frozen semen will remain the property of/and under control of the Stallion owner and may not be collected, stored, distributed, or sold by any other party and will only be shipped to approved veterinary hospitals. All frozen semen freight costs to breeding centre and for returning unused semen to semen storage facility are separate from this contract and payable by the mare owner. Semen must be used to breed 1 foal to the mare and not to breed another mare or breed more than 1 foal. Breeding by embryo transfer using the semen which results in more than 1 foal will incur a breeding fee for each additional foal.

**2) ASSIGNMENT:** This contract shall not be reassigned or transferred by the mare owner without written consent of the stallion owner.

**3) LIVE FOAL GUARANTEE:** In the event the foal is stillborn or dies within forty-eight hours of foaling, it is agreed that the mare owner is entitled to a free return to the said stallion for the mare, only in the breeding season immediately following the service to the said stallion. To be entitled to such subsequent breeding, the mare owner must notify the stallion owner within 48 hours from foaling. The mare owner must also give notification with a veterinarian's certificate of the foal's death within 14 days of such death. If the mare dies, is sold, or becomes unsuitable to breed, the right to a free return is null and void. Semen collection and shipping fees will apply to all rebreeds and will be the responsibility of the mare owner.

**4) COLLECTION AND SHIPMENT OF CHILLED SEMEN**: Chilled semen will only be provided after the booking fee is paid in full and the stallion owner has received a signed contract and a copy of the mare's registration papers. The Stallion Owner guarantees to ship the highest quality semen, however, will make no guarantees or warranties and shall not be held liable for contamination or damage of semen during or after shipment, loss of viability or any costs arising from shipments delayed, damaged, or lost in transit.

5) BREEDING CERTIFICATES: The mare owner is to notify the stallion owner of the pregnancy result at 45 days and supply the breeding dates to enable breeding certificate issue.

Breeding certificates will not be issued unless the above-mentioned mare is registered with the AQHA/ASH/EPRA at time of signing this contract. If a late stallion breeding return is required, the mare owner is liable to pay the late fee required by the relevant societies.
